I/we understand that whatever tuition assistance is granted by the Committee will terminate with the school year. Consideration IS determined by the financial circumstances of the family requesting tuition assistance, on the circumstances of the other families requesting assistance, and on the tuition assistance resources of the school, all of which vary from year to year. I understand that the process of consideration for this tuition assistance is done as confidentially as possible. I understand if financial need changes (child is moved to a class with fewer days, a sibling drops out, etc), the original scholarship monies may be adjusted for less assistance in order to reflect the change in this financial need. The identities of those requesting assistance are not revealed to the Committee, all family-identifying information is removed from all materials presented to the Committee that awards the scholarships. Only the Scholarship Committee Chair, the school director and office manager of the school learn the identities of the families who are awarded scholarship assistance. Other SYC committee members are never given this information. Teachers DO NOT KNOW which families receive tuition assistance.
